If you purchased a concession at Climate Pledge Arena between February 27, 2023 and July 23, 2023, you may have been assessed a 3% fee. If you were assessed a 3% fee, you may be eligible to receive a cash payment of ten dollars (\$10.00), plus the actual 3% fee paid or, if the 3% fee cannot be determined, an additional one dollar (\$1.00). **To participate, you must fill this Claim Form out completely and either (i) mail it to the address given below, or (ii) submit it online through the Settlement website below.** This Claim Form must be postmarked or electronically filed no later than **February 14, 2025**. If you provide incomplete or inaccurate information, your claim may be denied.

A complete list of events where the 3% fee was charged is included as an appendix to class notice. If you purchased a concession at Climate Pledge Arena between February 27, 2023 and July 23, 2023, please read the class notice (available at [www.SeattleArenaFeeSettlement.com](http://www.SeattleArenaFeeSettlement.com)) in its entirety and refer to the included Appendix before completing this Claim Form. Please note that the fee was not charged at Seattle Kraken games and therefore concessions purchased at Kraken games do not qualify for compensation.

To be eligible to receive any benefits from the settlement obtained in this class action lawsuit, you must complete or submit your Claim Form online or by mail:

The Settlement Administrator will make every attempt to match the last 4 digits of the card number to available purchase data. Supporting documentation is optional but may assist in determining your eligibility if we cannot match your card information to the available purchase data. Supporting documentation may consist of, but is not limited to, receipts from your purchase(s) and/or account statements. You may mark out any information that is not relevant to your claim before sending in the documentation.
